Symphony Sleep One Year* Limited Warranty

INNOVATIVE SLEEP TECHNOLOGIES PRODUCT WARRANTY TERMS

Innovative Sleep Technologies, L.L.C. ("Innovative Sleep Technologies") warrants that the product will conform to the manufacturer's specifications and be free from defect in materials or workmanship. The Purchaser's exclusive remedy for a breach of this warranty is limited to repair, replacement, or refund of the product at the discretion of Innovative Sleep Technologies. This warranty does not apply in any way to the contents of the product, including but not limited to, personal properties stored in the product by the Purchaser.

DURATION OF WARRANTY AND GEOGRAPHIC LIMITATION

This warranty expires 12 months after purchase, unless an extended warranty is purchased, and applies only to products located in North America. Time is calculated from the date of purchase of the product (proof of purchase required).

WHO IS COVERED

This warranty is only enforceable by the original Purchaser and is non-transferable and non-assignable.

QUALIFICATION

The product may only be returned to Innovative Sleep Technologies under the warranty terms detailed herein. Innovative Sleep Technologies, in its discretion, will determine whether the product qualifies for repair, replacement, or refund under this warranty. If it does not qualify for repair, replacement, or refund by Innovative Sleep Technologies, then Innovative Sleep Technologies will notify the Purchaser of the estimated cost of repair or replacement and will obtain Purchaser's authorization prior to proceeding. Innovative Sleep Technologies is not responsible for any labor or service charges related to the removal or installation (or reinstallation) of the product at any time or for any contents, personal properties, valuables or others that may be stored in the product.

Innovative Sleep Technologies will not pay any costs for repairs performed by anyone other than Innovative Sleep Technologies or its preauthorized designee, unless in each instance Innovative Sleep Technologies has given prior written approval of such repair. If a warranty repair is completed by an Innovative Sleep Technologies certified technician prior to obtaining an approval from Innovative Sleep Technologies, then Innovative Sleep Technologies reserves the right to refuse (i) payment to the service provider or (ii) reimbursement to the Purchaser. This warranty is void if the Purchaser replaces or attempts to replace or repair the product through a non-Original Equipment Manufacturer. If Innovative Sleep Technologies, in its discretion, determines that damage to the product is a total loss and that repairs would exceed the original cost of the product, Innovative Sleep Technologies reserves the right to decline to repair the product and choose an alternative warranty remedy. Any exception made to this warranty by Innovative Sleep Technologies, in its discretion, does not constitute a change in policy, nor is there a guarantee that the same decision will apply in the future.

WARRANTY COVERAGE AND LIMITATIONS

This warranty applies if a product is found by Innovative Sleep Technologies, in its sole discretion, to be defective in materials or workmanship. This warranty does not apply to:

1. Battery corrosion or replacement, normal wear and tear, scratches, abrasions, or maintenance.

2. Damage, defect, deterioration, or malfunction, of any kind, resulting from:

• improper installation, repair, operation, storage, or misuse of the product, or conduct of similar nature;

• failure to follow instructions on or provided with the product or by Innovative Sleep Technologies; natural disaster or severe weather events including earthquake, hurricane, tornado, tsunami, wildfire, or flood, etc.;

• acts of terrorism, war, explosions, etc.;

• use of paints, solvents, or other chemicals or matters that come in contact with the product;

• accident, abuse, negligence, use under conditions that the product is not designed for, use of parts or equipment that are not approved by Innovative Sleep Technologies, incorrect or unauthorized use, modifications, alterations, damage caused by fire or fire-fighting appliances and other similar causes of damage; or

3. Any defects or damage resulting from inadequate or incorrect transport to any location including return to Innovative Sleep Technologies, unless Innovative Sleep Technologies has explicitly accepted written responsibility for this.

ONSITE SERVICE

If Innovative Sleep Technologies approves onsite services to inspect and/ or repair the product at the product's location, then Innovative Sleep Technologies will arrange for a visit by an onsite technician. Replacements from Innovative Sleep Technologies will be shipped with prepaid shipping and handling. If Innovative Sleep Technologies determines that a product is defective, then it will facilitate the return shipping of the product from the Purchaser back to Innovative Sleep Technologies. The Purchaser should ensure that the product is packed in the original packaging, include proof of purchase and RMA Number, and mail the return to the following address:
